# SSCA OWNER RELEASE FORM

The SSCA rescue program works to place surrendered dogs into permanent, responsible homes, but assumes no responsibility for the potential adopter's character or suitability as an owner. While SSCA rescue will take all reasonable precautions, the releasing party agrees that the SSCA and the SSCA rescue program, its agents, members, and volunteers are not to be held responsible for the safety of this dog.

The undersigned hereby delivers possession and ownership of the dog to SSCA rescue; releases SSCA and the SSCA rescue program from any and all claims, demands, and causes of action with respect to ownership of the dog; and authorizes the SSCA rescue program to locate a home for the dog and deliver ownership and clear title to the recipient of the dog. The undersigned intends to convey full, complete, and unrestricted legal ownership of the dog to SSCA rescue by execution and delivery of this SSCA Owner Release Form.

The undersigned acknowledges that he/she may receive updates on the dog relinquished to SSCA rescue by contacting the SSCA rescue chair, but only if the adopting family agrees to supply updates, and no direct contact between the undersigned and the adopting family is allowed. The SSCA rescue program maintains the confidentiality of its adopters and will not release their contact information. In addition, the SSCA rescue program is under no obligation to, and will not contact, an adopter to ask for permission to release his/her contact information to the undersigned or to any other party.

The undersigned further agrees to indemnify, defend, and hold harmless SSCA, the SSCA rescue program, its officers, agents, members, and volunteers from any liability, loss, claims, demands, causes of action, or damages (including attorney fees) that such person may incur or sustain by reason of acceptance of the dog or any breach of this SSCA Owner Surrender Form by the undersigned.

I hereby relinquish all claims of ownership of the dog described above to SSCA rescue. To the best of my knowledge, this dog has never seriously bitten anyone or exhibited aggressive tendencies. I hereby indemnify and hold harmless SSCA, the SSCA rescue program, its officers, agents, members, and volunteers from any and all claims that may be brought for any and all claims of liability that may arise in the event the dog exhibits aggressive tendencies, transmits a contagious disease, or causes any loss or injury.
